

**TOWNSHIP OF EVESHAM
ORDINANCE NO. 17-7-2017**

**AN ORDINANCE OF THE TOWNSHIP OF EVESHAM
AMENDING CHAPTER 72 OF THE CODE OF THE
TOWNSHIP OF EVESHAM ENTITLED "FEES"**

WHEREAS, the Township has reviewed its fee schedule and determines to update the schedule to ensure that the fees are consistent with the cost of operation of certain facilities and to eliminate certain fees.

NOW THEREFORE, BE IT ORDAINED AND ENACTED, by the Township Council of the Township of Evesham, County of Burlington, State of New Jersey, that the Township Council does hereby amend Chapter 72 of the Code of the Township of Evesham to adjust certain fees for use of municipal properties and Township services.

SECTION 1. Section "I" of Chapter 72 of the Code of the Township of Evesham "Miscellaneous Fees and Services" is hereby repealed in its entirety and replaced as follows:

I. Department of Recreation and Open Space

(1) Rentals Fees

(a) Outdoor fields: no lighting

(a) Memorial Synthetic Turf Fields

- [1] Annual Fee to hang 3'x5' Banner \$500 per year

(b) Memorial 60/90 Baseball Field

- [1] Annual Fee to hang 4'x6' Banner \$400 per year
- [2] Annual Fee to hang 3'x5' Banner \$300 per year

(c) Diamonds at Arrowhead

- [1] Annual Fee to hang one to three 8'x8' Banners \$500 per year
 - [2] Annual Fee to hang Four (8'x8') Banners \$1,000 per year
- (New Sponsors Only)

(d) Banner Costs

- [1] Banner cost to sponsor \$300 per banner
- [2] Banner cost to make four banners for sponsor \$249 per banner

(e) Administrative Information

[1] Responsibilities of the Sponsor

- [a] Responsible for providing artwork/logo for the banner through email in PDF or EPS format.
- [b] Sponsor will receive a proof of their banner for approval before banner is completed
- [c] Aside from theft, vandalism and normal damage and wear and tear, any new banner replacement cost will be the responsibility of the sponsor. Each banner is estimated to last two to three seasons.

[2] Responsibilities of Evesham Township

- [a] Evesham Township agrees to furnish and hang your banner in a timely fashion
- [b] Banner will not be displayed until payment is received
- [c] Banner will be displayed at the designated field per each sponsor agreement
- [d] Banner will be displayed upon payment for one calendar year
- [e] Evesham Township reserves the right to remove all banners for any reason, and all banners will be removed and stored during the winter months.

[3] Recreation Commission Fees

- (a) Fees charged for various programs and classes shall be established by this Department with the approval of the Township Manager

[4] Security Deposits

- (a) Field usage single Day \$200
- (b) Field usage Multiple Days \$500

[5] Summer Camp Fees

- (a) Seasonal Half Day Camps \$250 (six weeks)
- (b) Seasonal Full Day Camps \$225 per week
- (c) Seasonal Full Day CIT Camps \$150 per week

[6] Miscellaneous Fees

- (a) Quarterly recreation programs \$30 to \$300 per program
- (b) Annual Vending permits, resident/non-profit \$100 per year
- (c) Annual Vending permits, all others \$200 per year

SECTION 2. Chapter 72 of the Code of the Township of Evesham “Miscellaneous Fees and Services” is hereby amended to include section “O” and is to read as follows:

O. Department of Public Affairs and Senior Services

(1) Rental Fees

SECTION 3. INCONSISTENT ORDINANCES:

All Ordinances and provisions thereof inconsistent with the provisions of this Ordinance shall be and are hereby repealed to the extent of such inconsistency.

SECTION 4. DECLARATION OF INVALIDITY:

If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this ordinance shall be deemed valid and effective.

SECTION 5. EFFECTIVE DATE

This Ordinance shall take effect upon final adoption and publication in accordance with the law.

Please take notice that the ordinance published herewith was introduced and passed on first reading at the Regular Meeting of the Township Council of the Township of Evesham in the County of Burlington, State of New Jersey, held on June 20, 2017, and said ordinance will be further considered for final passage after public hearing at a meeting of said Township Council to be held on July 18, 2017, at 6:30 P.M. in the Municipal Complex, 984 Tuckerton Road, Marlton, New Jersey, at which time and place all persons interested will be given an opportunity to be heard concerning such ordinance.
