

**TOWNSHIP OF EVESHAM
ORDINANCE NO. 8-5-2019**

**AN ORDINANCE OF THE TOWNSHIP OF EVESHAM
AMENDING CHAPTER 72 OF THE CODE OF THE
TOWNSHIP OF EVESHAM ENTITLED "FEES"**

WHEREAS, the Township has reviewed its fee schedule and determines to update the schedule to ensure that the fees are consistent with the cost of operation of certain facilities and to eliminate certain fees.

NOW THEREFORE, BE IT ORDAINED AND ENACTED, by the Township Council of the Township of Evesham, County of Burlington, State of New Jersey, that the Township Council does hereby amend Chapter 72 of the Code of the Township of Evesham to adjust certain fees for use of municipal properties and Township services.

SECTION 1. Chapter 72 of the Code of the Township of Evesham "Miscellaneous Fees and Services" is hereby amended as follows:

Miscellaneous fees and services

§72-1 (B)(2)(a) is amended to change the fee to \$10

§72-1 (I)(1)*Rental fees* (a)*Outdoor fields: no lighting* (1)through(2) is repealed in its entirety

§72-1 (I)(1)(b) through (f) titles are amended to read as follows:

- (a) Outdoor grass fields
- (b) Outdoor Synthetic Turf Fields (M1 and M2)
- (c) Blue Barn (Indoor Courts and Rooms)
- (d) Outdoor Basketball & Tennis Courts
- (e) Bocce Courts

§72-1 (I)(1)(g) is amended to read as follows:

- (f) Hockey Rinks (Dek Surface rentals are \$10 more per hour)
 - [1] Residents
 - [a] Individuals/groups \$20 per hour
 - [b] Nonprofit groups \$20 per hour
 - [c] Commercial \$25 per hour
 - [2] Non Residents
 - [a] Individuals/groups \$25 per hour
 - [b] Nonprofit groups \$20 per hour
 - [c] Commercial \$30 per hour

§72-1 (I)(1)(h) title is amended to read as follows:

- (g) Field Parking

§72-1 (I)(1)(i) is amended to read as follows:

- (h) Diamonds at Arrowhead
 - [1] Residents

[a]	One Field	\$90 per hour

§72-1 (J)(2) through (4) is repealed in its entirety and replaced to read as follows:

(2) Automated containers

(a) Ninety-five gallon \$75.00

(3) Road opening permit

\$125.00

(4) Bulk trash pickup at request of the resident

(a) Other than regularly scheduled quarterly pickups \$40.00

§72-1 (L) *Sponsorship Fees* (1)(a) through (b) *Golf course tee sponsorship* is repealed in its entirety.

SECTION 2. INCONSISTENT ORDINANCES:

All Ordinances and provisions thereof inconsistent with the provisions of this Ordinance shall be and are hereby repealed to the extent of such inconsistency.

SECTION 3. DECLARATION OF INVALIDITY:

If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this ordinance shall be deemed valid and effective.

SECTION 4. EFFECTIVE DATE

This Ordinance shall take effect upon final adoption and publication in accordance with the law.

Please take notice that the ordinance published herewith was introduced and passed on first reading at the Regular Meeting of the Township Council of the Township of Evesham in the County of Burlington, State of New Jersey, held on April 16, 2019, and said ordinance will be further considered for final passage after public hearing at a meeting of said Township Council to be held on May 7, 2019, at 7:00 P.M. in the Municipal Complex, 984 Tuckerton Road, Marlton, New Jersey, at which time and place all persons interested will be given an opportunity to be heard concerning such ordinance.
