Thomas Trautner, Attorney for Applicant Overview

- Applicant is seeking a third extension for a project that was originally approved on December 17, 2012
- Prior approval was to permit an additional 27 units with 18 Alzheimer unties
- Sought 1 year extension previously on June 18, 2016
   Sought 1 year extension previously on June 19, 2017
- CareOne is looking to finish interior modifications. Modifications to the skilled nursing facilities was completed in 2017 and modifications to the residential rooms is ongoing and should be complete within 2018
- Applicant wants to re-evaluate interior of the facility before pursuing a new project
- CareOne will evaluate the approved project and determine how to move forward
- If they do not move forward with work approved in 2012 and under the third and final extension, the applicant will be required to return for board approval.
