1. Church of St. Joan of Arc – Preliminary & Final Major Site Plan

Applicant proposes a 3,633 sq. ft. rectory and driveway on the existing 11.8 acre

Robert Baranowski, Jr., Attorney for Applicant

Applicant Attorney Overview:

- Existing rectory is occupied by 3 priests
- Shared with offices used for parish business
- Existing rectory/building will be used for offices
- New building/rectory will give priest separate living space and privacy

Applicant's Witnesses Sworn:

- Msgr. Richard LaVerghetta Pastor
- Brian Cleary Engineer The Pettit Group, LLC
- Dan Nichols Architect Holiday Architects Inc.

Msgr. Richard LaVerghetta explained that the new facility would be the new seperate living quarters for the priests serving the parish

The new rectory will be living quarters for the 3 parish priest and will separate the living quarters for the them from the parish offices.

This will provide privacy for the priest and add additional office space for the parish

Brian Clearly, Engineer with The Pettit Group, LLC testified the applicant is Proposing to construct an approximate 3,633 sq. ft. rectory and driveway at the existing site, consisting of 3 bedrooms. Driveway will be connected to the existing parking area. Existing parking spaces will be relocated but there will be no overall loss in the number of parking spaces.

He described the proposed additional landscaping and lighting that will be provided

No additional stormwater facilities are need

Impervious coverage increase is minimal – increasing to 48.3% where 50% is permitted

<u>Dan Nichols, Architect</u> reiterated that the rectory was essentially a 3 bedroom house for the parish priests. The bedrooms are setup as suites for the priest's living quarters. He testified the façade is brick with roof shingles and will match as much as possible the existing buildings on site.

Applicant ends testimony

<u>Leah Furey</u>, <u>Planning Board Planner</u> considered the July 3, 2018 review letter prepared by she and Nancy Jamanow, Director of Community Development, and indicated the applicant has satisfied all the conditions of the report and indicated that no variances were necessary. Also recommended was the granting of the submission waivers requested.
