Presentation of updated Environmental Resources Inventory (ERI) and public hearing on the adoption of the ERI as technical appendix to the Township Master Plan

- Current Township Environmental Resource Inventory is 10 years old
- Time to be updated
- Technical Appendix to the Master Plan
- Background for the Master Plan
- Use information from the ERI to make decisions; then use for density, preservation, where infrastructure should go etc.
- Document has a lot of value
- Policy recommendations and changes in the future
- Will be able to make recommendations and refer developers to it and such in the future

Dominic Mondi

- Environmental Resource Inventory Presentation
- Adoption 2009
- Partnership with Delaware Valley Regional Planning Commission
- Exists as a Reference Guide but currently not tied to Master Plan
- 2015 decided to review and update
- Revised is review of all data points that had old reference which needed updating
- Collected information and researched among team members
- Also contains many maps and visual reference data
- GIS map updates completed
- New document looks very similar but with updated references, etc.
- ERI will be attached to Master Plan as appendix; elevates it as a reference for Planning and Zoning; redevelopment down the road
- Not a policy setting document but more information
- Good information to help make decisions

Board Comments

- Mr. Parikh asked Leah if this was a binding document to the Master Plan
- Leah answered that it was not really binding; technical foundation but when developers do Phase I this is a resource they can go to directly
- Mr. Parikh asked if it references the definition of a playground
- Leah advised that it does not; this is not the Open Space and Recreation Plan this is Environmental Resources
- ERI is background for the Open Space and Rec Plan
- Open Space and Rec Plan inventories all of the open space and recreational facilities public and privately owned and makes recommendations to open space acquisitions or preservation in the future
- It is non-binding document; this one does not make recommendations; it's a factual appendix
- This is a reference

Dominic Mondi

- ERI ties into plans for Sustainable Jersey Program and Certification
- Plan for Silver Certification for this year
- Priority item ERI updated within last 10 years and an appendix to Master Plan
- Improve town efforts
- Make recommendations to Council to make this document an Appendix
- Added benefit of helping Township to earn a higher certification Sustainable Jersey
- Document not bound and very large; list of data points and items to review
- Process and how it is used
- Not specifically in the Township's Charter but certainly within the purview
- Township Planner and Administrative Secretary worked hard to help get here
- A lot of volunteers also involved and put a lot of time into it

- Leah advised that there was a lot of expertise and resources on the Environmental Commission which was very helpful
- Maps were difficult to update; used branch of ARH to assist
- Best way to use is as an attachment to the Master Plan

- Hope for it to be available on the Evesham Township website once it is updated
