Proposed lot width - Lot 5 - 46.20 ft., Lot 6 - 52.14 ft.

Lots to be created for residential use

Township is in talks with Habitat for Humanity for construction of Affordable units - twin/duplex structures – no construction plans at this time

Mr. Matlack referenced Proposed Lot Line Adjustment plan dated 6-18-21 prepared by CME – relocation of lot line

Lot line adjustment would allow for development of each property in a manner Consistent with the density of the surrounding area

A condition of approval should include submission of a minor subdivision plan and meets and bounds descriptions prepared by a licensed Land Surveyor 1200 sq. ft unit would be acceptable for proposed Affordable Housing
