Applicant received Final Site Plan approval 12-6-2008 – PB15-15F

Amid the COVID-19 Pandemic, Legislature passed the 2020 Permit Extension Act. The 2020 PEA tolled approval which were valid as of March 9, 2020 until the end of the public health emergency, and also provided that no approvals would expire for at least six (6) months after the end of the public health emergency, provided such approvals were registered. The public health emergency was ended on July 4, 2021. The Applicant registered the Approval under the PEA, and accordingly, the Approval will not expire on or about April 1, 2022

The applicant filed this application on March 29, 2022

The prior approval is for a convenience store and retail building
