Jenizza Corbin, Planner, Remington & Vernick Engineers, Inc Ms. Corbin presented to the Board an overall view of the plan OSRP was prepared in accordance with the guidelines and requirements of NJDEP's Green Acres Program Plan should be reviewed every 10 years but amendments can be made any time This process began in August, 2022 Input received from Township staff, Professionals, Black Run Preserve, Environmental Commission, Historic Preservation and public. A draft of the plan was developed and has since been revised There have been 2 public meetings, this meeting serves as the 3rd The goals established in the 2021 OSRP remain applicable (as listed on page 18 of plan) with the addition on one new goal – Create welcoming, accessible, and inclusive programs, services, and facilities for all ages and abilities

Ms. Corbin went over Section 3 – Inventory describing the inventory of private and public land by ownership

Ms. Corbin went over the Needs Analysis & Resource Assessment summary of the findings of the plan.

Ms. Corbin went over Section 6 – Action Plan Many of the efforts/action items from the 2012 OSRP are continued in this Plan update in addition to new action items, including:

Adopt an Inclusive Policy

Fire Management

Environmental Education & Outreach

Revegetation/Reforestation

Land Preservation & Protection – Township is actively pursuing. Focus Areas include the Headwaters Area, Southern Forest and East-West Connector Area,

Greenways – as in the 2012 OSRP (Barton Run/Black Run, Rancocas, Haynes Run, Mullica Greenways)

Circulation Plan- Township should investigate for an updated plan Complete & Green Streets Policy – is being recommended Historic Properties

Park & Open Space Improvements –

Park signage Beagle Club

Black Run Preserve – this is an opportunity to develop a Master Plan for the Black Run Croft Farm – Croft Farm Management Proposal – recommended that a long-term plan be done Blue Barn Central Community Park – work at Evesboro Downs has been done through the years Outdoor Field Lighting

Indoor/Outdoor Recreation Facilities to possibly include Field Bubble, Pickleball, Disc Golf, Street Hockey, Lacrosse/Hockey, Volleyball, Fieldhouse, Natural Play Space

Ms. Corbin provided an overview of the open space inventory in the Township, including the existing and proposed open space inventory.

Ms. Corbin addressed the numerous comments that were received, including technical and substantive comments and how they were incorporated into this plan. Some public comments were also presented and addressed with responses as to the:

Potential Blue Barn expansion Modifying plan document title Contaminated sites Hockey rinks availability Desire for no mow areas in Central Community Park Inclusion of block and lots Determination of the proposed open space parcels by EC Proposed improvements at Savich Field Removal of invasive plants and planting native plantings Coordination with HPC Verification of open space parcels and contaminated sites in Kings Grant Desire for zoning changes to Evesham Headwaters and Southern Forest Area Desire for splash pads and sledding hill Recommendation for Shared Services with the Field House at Marlton Assembly of God Walking trails improvements Additional lighting at dog parks

Ms. Corbin also provided that some comments were received regarding establishing a Township-wide "Friends of Evesham Open Space"; installing wildlife friendly boxes

for birds, owls, and bats; and allocating/prioritizing of funding for open space acquisition, which should be for the discussion of the Planning Board.

Ms. Corbin identified several proposed open space parcels for discussion with the Planning Board.

Ms. Corbin proposed additional changes to the plan including the removal of the total acreage of the proposed open space inventory, as it is not accurate. Second is the removal of duplicated block and lot information ; and updating Map #10 Proposed Open Space to remove several parcels that are already existing open space, which the GIS team will address.

Board Comment

Deputy Mayor Freeman – is reference of acreage should and +/- be noted Ms. Corbin – recommends the removal of the number given

Mayor Veasy – recommended purchase of Open Space Parcels – some are privately owned Ms. Corbin – recommendation from the Environmental Commission is when these parcels become available Township should look in to it Board Member Everhart – EC would like the Township to consider this? Ms. Corbin – yes Deputy Mayor Freeman – suggest the wording be changed Board Member Higginbotham – suggest – these parcels along Greenway – add land that borders waterways Mayor Veasy – what is the benefit of the Township purchasing this land Michelle Taylor – Taylor Design – purchase would not include the home – and the waterway/greenway could be an easement Mayor Veasy suggests that in Chapter 3 Section 3.3 Potential Open Space/Parks System Inventory – be worded differently as not to confuse the meaning

Mayor Veasy asked that Kessler Field be add to 4.2.7 Area G-Census Tract

Chairman Freidman – asking about process to Ms. Corbin – are you going back to the people who gave comments

Ms. Corbin – they have been addressed in the Plan Chairman Freidman feels the Board need more time

Board Member Everhart asked for a paper copy of the power point presentation Ms. Corbin – will send to members

Chairman Friedman recommends that the Board appoint a group to review the plan Mr. Karp – a sub-committee can be formed – 4 members

Mr. Rijs – suggest the committee meet after the May 1st Environmental Commission meeting so that their recommendations can be included, therefore recommends that this be scheduled for the May 15th Planning Board meeting

Board Member Killion-Smith has some concerns about the mention of shedding hills proposed and the liability on the Township

Mr. Karp – this would be reviewed by the Township's Governing Body

Deputy Mayor Freeman – under the Active/Inactive list, should the Barton Run Swim Club be included? Ms. Taylor – this is privately owned

Board Member Everhart – after the May 15th meeting, what is the process Mr. Karp – at that meeting the Planning Board would take action to recommend to the Governing Body the adoption of this Plan Ms. Taylor – the Planning Board would be putting it into a Document/Plan and presenting to the Governing Body

Work done by the Commission included inventory of parcels, water quality, habitat. Referred to Maps 5 & 6. Block and Lot sheet is not inclusive. Hope that there would have been more conversation in the process. Feels that with the next Environmental Commission being May 1st and getting comments back for the May 18th PB meeting is a short period of time

Deborah Larsen

Owns 3 properties that are on the block and lot list Asked if she would be forced to have a conservation easement on properties Mr. Karp – you would not be forced

Ila Vassallo Thanked everyone who put work into this document

Remington & Vernick, Environmental Commission and Taylor Design met back on 9/14/2022 with the understanding that dialogue would be back and forth Exchange of information did not happen Commission's intent was that they would be more involved Asked is PB received comment that were submitted Economic benefits to acquiring land should be a consideration Page 6 April 20, 2023

Paul Garver – Historic Preservation Commission Applauds the efforts made on this plan Would like to bring attention to the historic properties – Croft Farm, Beagle Club Applauds the Township on acquiring the Beagle Club Would like to mention the Cooper-Evans House – it is a shame and an embarrassment – hoping there is a way to preserve it Suggests a historic consultant be considered – recommends Margaret Westville – a project she is responsible for is the Thomas Evan House located at the golf course

Reason for being here is for the preservation of her neighborhood – Brush Hollow Pickleball field is very active with league play, outside residents. Concerned about traffic, infrastructure and safety

Mary Winston

Referred to Map 10 and questioned the area where it is labeled County of Burlington – is this an open space piece – there is no access to this parcel

Gail Hodlofski

About the pickleball fields – would like to clarify that they should be 600' from a resident Clarification should be on hours of operation, noise, walking paths, parking, allotted times, capacity of players
